## Automate dental claims with fast, easy electronic submission

Imagine a claims process with less paperwork that uses less time. Now imagine that process possibly costing less than your current one.

It's called **Electronic Data Interchange (EDI)**. It's a complete, claim-to-compensation process for filing electronically. Using EDI, you can file claims — with all attachments — get a remittance advice, and have payment directly deposited, all from your computer.

Submitting a claim with EDI gets the ball rolling sooner, but it's just step one. You can track the progress of each claim and automate payment too.

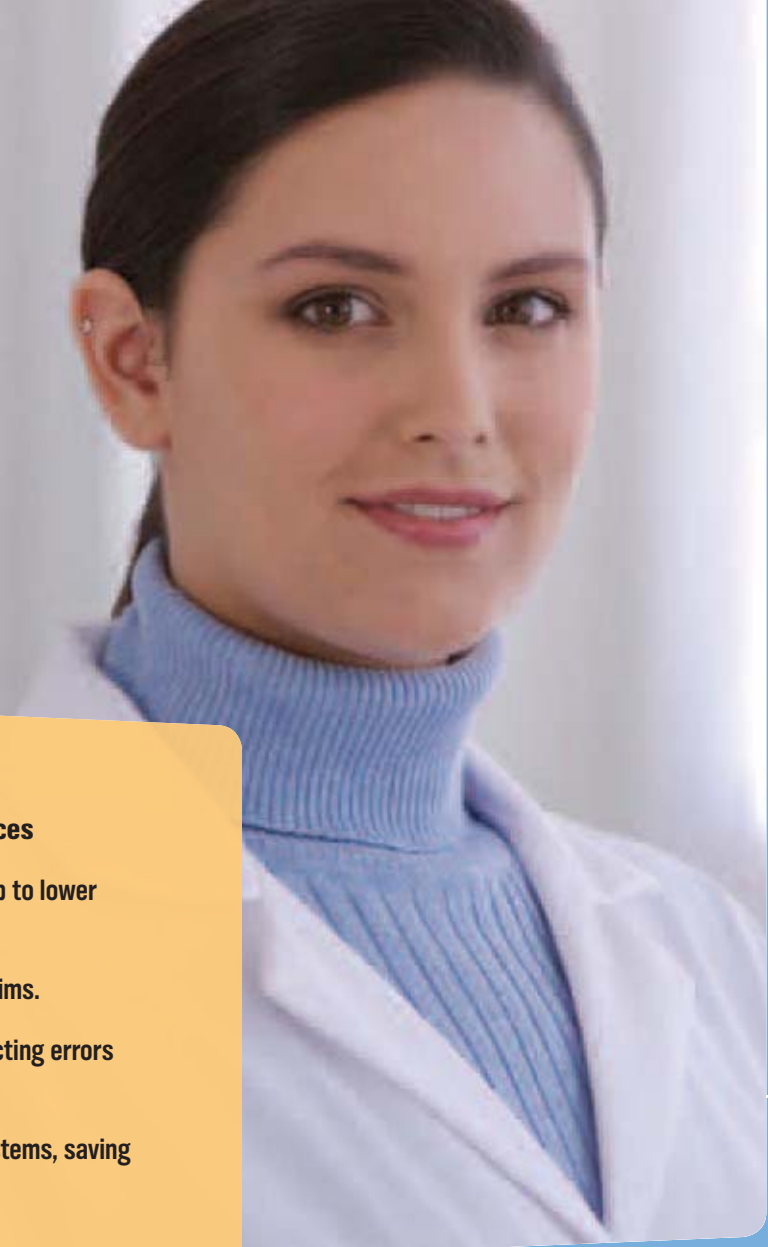


### EASY TO TRACK.
